WEDDING TERMS AND CONDITIONS

All Weddings booked at Singing Hills Golf Course Ltd. shall be subject to the following terms and conditions:

Definitions

- "We" and "Us" shall mean Singing Hills Golf Course Limited.
- "The Client", "You" and "Your" shall mean the person(s)/company responsible for commissioning and payment of the wedding reception
- The "Contract" shall mean the agreement between Singing Hills Golf Course Limited and the Client for a specific booking detailed on the wedding booking form.

1. Provisional Reservations

- i) A provisional booking will be held for 14 days without obligation. This booking will automatically be released unless written confirmation and a deposit are received from you.

2. Confirmation between Singing Hills and The Client

- i) Once a non-refundable deposit of £200.00 is received from you, we will provide you with written confirmation of the booking.
- ii) Final numbers should be confirmed seven days prior to arrival (see section 4). Final timings, menus and any special requests must be provided to us at least eight weeks prior to arrival.

3. Charges and Payments

- i) An advance deposit of £200.00 is payable to confirm the booking.
- ii) A Pro-Forma Invoice will be issued when numbers, food, wine and entertainment have been decided of which 50% will be required no later than 6 weeks prior to the event. Confirmation of final numbers must be confirmed **14 DAYS** prior to the event. The balance of this invoice is required **7 DAYS** prior to the Wedding together with the final numbers of guests attending.
- iii) All rates include VAT at the prevailing rate and are subject to alteration should that rate change.
- iv) Children attending the Wedding aged between 4 and 12 years of age, who require half portions, will be charged at 50% of the adult price (children 13 years and over will be charged full price). Children aged 3 years and under, who require food, will be charged at a third of the adult price.

4. Amendments by the Client

- i) Amendments to your numbers and/or arrangements must be made known to us as soon as possible and confirmed in writing.
- ii) Charges may be made for any reductions in numbers booked at our discretion.
- iii) The acceptance of any increase over previously advised numbers is at our discretion.

5. Cancellation by the Client

- i) In the unfortunate circumstances that you have to cancel or postpone your confirmed booking at any time prior to the event, we will make every effort to resell the space on your behalf. We do reserve the right to charge a cancellation fee unless a booking is obtained for the same dates on no less favourable terms.
 - a. Cancellation between 3 – 6 months = 30% of the total anticipated charges.
 - b. Cancellation between 1 – 3 months = 50% of the total anticipated charges.
 - c. Cancellation between 1 week and 1 month = 75% of the total anticipated charges.
 - d. Cancellation at less than seven days = 100% of the total anticipated charges.
- ii) Any cancellation, postponement or partial cancellation should be advised to us by telephone and put in writing by you and will be effective from the date received by Singing Hills.
- iii) No deposits will be refunded.

6. Amendment or Cancellation by Singing Hills

- i) Should we for any reasons beyond our control need to make any amendments to your booking, we reserve the right to offer an alternative choice or similar suitability.
- ii) We may cancel the booking:-
 - a. If Singing Hills or any part of it is closed due to circumstances outside our control.

- b. If you breach any terms of this agreement.
- iii) In such events Singing Hills will refund any advance payment but will have no further liability to you.

7. Clients Use of Singing Hills

- i) We reserve the right to approve any externally arranged entertainment, services or activities that you have arranged and cannot accept liability for any resultant cost.
- ii) Should any of your guests be unable to correct any aspect of poor or unacceptable behaviour, they may be asked to leave the premises. Should this occur no monies will be refunded to you.
- iii) No wines, spirits or foods brought to Singing Hills may be consumed without written consent from us.
- iv) We shall not be liable for any failure to provide or delay in providing facilities and service as a result of events or matters outside our control.
- v) You are responsible for ensuring that any band or musician employed by you complies with the requirements of the Performing Rights Society.
- vi) You are required to do all that is necessary to enable us to comply with licensing and other relevant legislation.
- vii) You should not carry out any electrical (or any other) works at Singing Hills including amplification and lighting without written consent from us.
- viii) You should not bring dangerous or hazardous items into Singing Hills and should remove such items when requested to do so by a member of Singing Hills' management or any other authorised person.
- ix) The event shall terminate at the time specified.

8. Insurance

As we do not accept liability for cancellations or abandonment, we strongly recommend you take out insurance cover for your event for a minimum amount, based on the anticipated cost of your wedding. Insurance call also cover non-appearance of entertainment, property damage at or to the venue or its contents, third party bodily injury, third party damage and loss or damage to your property or equipment including that hired by The Client. We do not accept liability for these.

9. Liability

- i) Singing Hills will be liable to the client and/or persons attending the event for injury to persons or loss or damage to property only where and to the extent that it has been negligent but otherwise will be under no liability to them whatsoever.
- ii) The Client will be liable for any loss or damage to Singing Hill's property including walls, light fittings and equipment (including items hired for their use) or injury to any person including Singing Hills' staff and shall indemnify Singing Hills.

10. General

- i) We will take all reasonable steps to fulfill the reservation to the best of our ability and in accordance with the detail provided. However, we reserve the right to provide alternative goods and services of a least an equivalent standard at no additional cost to you.
- ii) You shall not be entitled to utilise Singing Hills' facilities, other than for the purpose stated overleaf, without prior written approval from us.
- iii) Whilst we have taken all reasonable steps to ensure that the information contained in brochures, tariffs, leaflets and advertisements is accurate, we reserve the right to alter, substitute or withdraw any service, facility or amenity without notice if necessary.
- iv) Notwithstanding anything contained in these Terms, we will not be liable for any failure to perform our obligations to you in whole or part as a result of any of the following circumstances:-
 - a. Strikes or any other industrial action(s)
 - b. Fire or flood at or near Singing Hills
 - c. Civil unrest, dispute or commotion
 - d. Act of God
 - e. Any other circumstances beyond our reasonable control
- v) No variation of these conditions shall be effective unless in writing and signed on behalf of both Singing Hills and The Client.
- vi) Flower arranging and setting up is permitted before midday. The Restaurant and Pavilion Bar Lounge are available for the wedding party to arrive from 3:30pm onwards.
